The meeting was called to order by Deputy Supervisor Edick at 7:30 P.M. All present joined in the Pledge of Allegiance.

**Approval of Minutes:**

Councilor Bick moved the adoption of a resolution to **Approve** the Minutes of Regular Town Board Meeting September 7, 2011. Motion was seconded by Councilor Bray.

Deputy Supervisor Edick stated that there will be no action on the first four items as there are still some drainage issues to be addressed and some incomplete information.

**Correspondence:**

Deputy Supervisor Edick stated that he had just received information that CSX will be closing part of Route 31 for maintenance on the train tracks. This will last for 36 hours and will take place near the Key Bank between Kohl's and Route 57.

Deputy Supervisor Edick asked if anyone wished to address the Board on any items not on the agenda.

Russ Mitchell of Clairmont/Four Seasons Development stated that he has a few neighbors that have brush and debris in their side yards on Henry Clay Boulevard.

Mr. Mitchell asked if the Town Highway Department picks it up or if the County Highways picks it up. Councilor Weaver explained that the County maintains Henry Clay but that they do not collect brush. It was explained that in years past the Highway Department did a fall and a spring pick up of large brush however in effort to be fiscally conscientious, this service is no longer available. Mr. Mitchell asked that perhaps the highway department could make an exception and pick up the large amount of brush that has been out all summer and is beginning to smell. Councilor Weaver explained that the highway department could not even get the equipment onto the property. Mr. Mitchell asked what the residents should do and the Board suggested that the resident hire an independent contractor. In addition Mr. Mitchell should contact the Planning Department (Code Officer).
