There will be new asphalt driveway as well as parking. The bio retention pond will be in the back of the site, as well as a berm.

The sheds have been removed from the plan. The Septic has been looked at and will accommodate the existing building and the addition. The addition will have no sprinklers; therefore the applicant will add a fire hydrant. They will install an 8 foot fence along the back, the building will have split face block and so will the addition.

Karen said the code only allows a 7 foot fence without a variance. She referred to the code page 230.77.

Karen said the Board needs a trip generation as well as the DEC letter for the file. Karen explained there can no longer be storm water ponds in a landscape buffer.

Karen said the county comments included modifications, No parking, loading or backing up into the County right of way. And just a reminder I-1 activity has to be inside the buildings. Structure design has to be compatible to Surrounding and adjacent property.

Karen opened it up to the Board. Michelle asked if they had received a letter from SHPO. Brian said they had.

Ron had some comments on stormwater; he will work with the applicant on the issues.


